Securities and Exchange Board of India ("SEBI") and the approval of the unitholders of the Trust as required under Regulation 9(15) of the InvIT Regulations obtained from the unitholders in the extra- ordinary general meeting held on 14 November 2022, Highway Concessions One Private Limited ("HC 1") and HC One Project Manager Private Limited ("HC One") was appointed as the new Investment Manager and Project Manager of the Trust respectively in place of Virescent Infrastructure Investment Manager Private Limited ("erstwhile Investment Manager") and Virescent Renewable Energy Project Manager Private Limited ("erstwhile Project Manager of the Trust"). The appointment of the new Investment Manager was also approved by the Board of erstwhile Investment Manager of the Trust vide its circular Resolution dated 19 October 2022. Consequently, Highway Concessions One Private Limited and HC One Project Manager Private Limited have been acting as the new Investment Manager and Project Manager of the Trust effective from 23 November 2022 and 14 November 2022 8 During the guarter ended 31 December 2022, three of the project SPV's Viz. Godhra Expressways Private Limited ('GEPL'),

Dewas Bhopal Corridor Private Limited ('DBCPL) and Ulundurpet Expressways Private Limited ( "UEPL") has filed the petition with the Hon'ble National Company Law Tribunal, Mumbai Bench ('NCLT') for capital reduction under Section 66 and other provisions of the Companies Act, 2013. The said reduction was approved in the extraordinary general meeting in the respective Project SPVs which were held on 19 October 2022 for GEPL and DBCPL and on 29 November 2022 for UEPL. Pursuant to capital reduction scheme, the shareholders shall be entitled to receive an amount based on the fair market valuation of the equity shares of the aforesaid project SPV's and the said consideration shall be presented as loan outstanding to the shareholders. Currently, admission order has been received for the applications in DBCPL and GEPL by Hon'ble NCLT and necessary notices have been given to the Regional Directors, ROC and creditors of these two SPV's, however in UEPL admission order is yet to be received and necessary notices are yet to be given to the above mentioned parties. Final order is awaited in all the SPV's, therefore no impact recorded in the special purpose unaudited consolidated interim financial statements for the nine months period ended 31 December 2022.
