Dear Sir/Madam,

This is to inform you that in view of 21 days' nationwide lockdown advisory announced by the Government of India and other authorities to contain the spread of Corona Virus disease (COVID-19), and with an objective to ensure the safety and health of the employees and their families, at all its offices and manufacturing locations, the Company has decided to temporarily suspend all the manufacturing operations of its plants situated at Raipur and Raigarh both located in the State of Chhattisgarh with effect from 25th March 2020 till further notice.

Even though the manufacturing units with continuous operation and the units producing essential commodities (Steel is classified as an essential commodity under the Essential Services Maintenance Act, 1981 (ESMA)), are exempted from the lockdown announcement, the Company has decided to temporarily shutdown and suspend all plant operations, supporting the initiative of our Hon'ble Prime Minister for containment of COVID19 epidemic in the country.

The Company will continue to closely monitor the situation and take appropriate action as per the directions issued by regulatory authorities from time to time, keeping in view the health and safety of all of its employees and their families and the interest of the nation at large.
