Sub: Intimation pursuant to Regulation 30 read with Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015;

Dear Sir,

This is in reference to our intimation dated 26th March 2020, with respect to temporary suspension of all the manufacturing operations by the Company at its plants situated at Raipur and Raigarh, Chhattisgarh, with effect from 25th March 2020 till further notice, in view of nationwide lockdown advisory announced by the Government of India and other authorities to contain the spread of Corona Virus disease (COVID-19).

The aforesaid temporary suspension of plant operations was taken, even though the manufacturing units with continuous operation and the units producing essential commodities (Steel is classified as an essential commodity under the Essential Services Maintenance Act, 1981 (ESMA)), are exempted from the lockdown announcement, supporting the initiative of our Hon'ble Prime Minister for containment of COVID19 epidemic.

In continuation of the aforesaid disclosure, this is to inform you that the Company has restarted the integrated steel manufacturing operations at the plant of the Company located at Village Naharpali, Tehsil Kharsia, District Raigarh, Chhattisgarh, with effect from 02nd May, 2020. The manufacturing operations at the plant of the Company located at Raipur, Chhattisgarh will continue to remain temporarily suspended till further notice.

The manufacturing operations of the Company will be conducted in compliance with the relevant guidelines/advisory issued by the Government and authorities, for taking necessary measures and precautions, for the containment of COVID-19, including measures like maintaining social distancing and restriction on number of workers, till such restrictions are removed by the authorities.

This is for your information and record and for further dissemination to the shareholders of the Company.
