- 3. The authorization granted vide letter no. 751/BMW/HO/CECB/2019 Raipur, dated 10/05/2019 to occupier of facility i.e. Maina Devi Clinic (30 Beds), Monnet Ispat & Energy Ltd., Naharpali, Distt. Raigarh (C.G.) is hereby granted an authorization for a facility for segregation, collection, reception, storage, transport, treatment and disposal of Bio-Medical Waste at the premises situated at Monnet Ispat & Energy Ltd., Naharpali, Distt. Raigarh (C.G.).
- 4. This renewal of authorization shall be in force for period from 04/05/2020 to 03/05/2023.
- 5. This renewal of authorization is subject to the conditions stated below and to such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act 1986.

TERMS & CONDITIONS OF AUTHORIZATION

- 1. The authorization shall comply with the provisions of Environment (Protection) Act, 1986 and the rules made there-under.
- 2. The occupier shall obtain membership from CBWTFs for Bar Coding and final disposal of their Bio Medical Waste.
- 3. The authorization or its renewal shall be produced for inspection at the request of an officer authorized by the prescribed authority.
- 4. The person authorized shall not rent, lend, sell transfer or otherwise transport the Bio-Medical wastes without obtaining prior permission of the prescribed authority.
- 5. Any unauthorized change in personnel, equipment, or working conditions as mentioned in the application by the person authorized shall constitute a breach of his authorization.
- 6. It is the duty of the authorized person to take prior permission of the prescribed authority to close down the facility and such other terms and conditions may be stipulated by the prescribed authority.
- 7. The occupier shall submit in annual report in enclosed form-IV by 30th June every year to concern Regional Office of the Board.
- 8. No untreated Bio-Medical waste & shall be kept stored beyond a period of 48 hours. Provided that if for any reason it becomes necessary to store the waste beyond such period, the authorized person must take permission of prescribed authority and take measures to ensure that the waste does not adversely affect human health and the environment.
- 9. The occupier shall take necessary action for the treatment of effluent generated from the hospital so as to meet the standards prescribed under Water (Prevention and Control of Pollution) Act, 1974. Standard limit is given below:-

A. Water (Prevention and Control of Pollution) Act, 1974

- 1. Hospital shall improve their existing water pollution control facilities and operate properly so that the treated effluent could be achieved within the prescribed standards.
- 2. Hospital shall ensure that there is no discharge of effluent or any seepage of waste water outside of Hospital premises.
- 3. Hospital shall install rain water harvesting system for recharge of ground water.
- 4. Bio-medical waste shall be collected and proper disposed in deep burial methods by using deeppit and sharp pit.
- 5. Hospital shall maintain good house keeping practices within the hospital premises.
- 6. Extensive tree plantation shall be carried out in open areas available within & around the hospital premises.

B. Air (Prevention and Control of Pollution) Act, 1981

- 01. Hospital shall improve their existing air pollution control facilities and operate these properly so that the emission could be achieved within the prescribed standards.
- 02. Bio-medical wastes shall be treated and disposed off in accordance with Schedule-I , and in compliance with the standards prescribed in Schedule-V.
- 03. Segregation, packing, transportation and storage of Bio-medical wastes shall be in accordance with rule 6.
- 04. The Consent is granted to operate the facility for collection, reception, treatment storage, transport & disposal of Bio-medical wastes of waste category type red, yellow, blue and white generated from your Hospital.
- 05. All Staff, including those engaged Bio-medical wastes, collection, reception, treatment, storage, transportation and disposal should have regular medical checkups.
- 06. Working of the Bio-medical wastes management system shall be reviewed at regular intervals and modifications if any, required shall be carried out promptly.
- 07. Maintenance of records shall be in accordance with rule 11.
